Danville Area Community College is committed to providing quality, innovative, and accessible learning experiences which meet the lifelong academic, cultural and economic needs of our diverse communities and the world we share.

About DACC

Danville Area Community College is an accredited public two-year community college providing higher education opportunities for youth and adults in East Central Illinois. Established initially as an extension center of the University of Illinois in 1946, DACC became a public junior college under Danville Public Schools in 1949, and received the name Danville Junior College in 1951. In June 1966, the College became an independent two-year area college with its own Board of Trustees and junior college district. The name Danville Junior College was changed to Danville Area Community College in 1979, to be more reflective of the services rendered. District #507 encompasses high school districts in Vermilion, Edgar, Iroquois, Ford, and Champaign counties with an estimated population of 89,000.

DACC's New President



Dr. Nacco presided over his first DACC Commencement on May 19, 2017, in the Mary Miller Gymnasium.

A record number of the College's 550 graduates participated in the ceremony.

On Aug. 15, 2016, Dr. Stephen Nacco began service as the seventh president in Danville Area Community College's illustrious 70-year history.

Before joining DACC, Dr. Nacco served as vice president of administrative services and executive

assistant to the president at Union County College in Cranford, N.J. Prior to Union County College, Dr. Nacco was executive director of college relations at Brookdale Community College in Lincroft, N.J. and senior director of customer relations for MTA New York City Transit. He began his career as a full-time instructor in English at St. John's University.

As the DACC president, Dr. Nacco strives to continue the progress that DACC has enjoyed under the leadership of his predecessor, Dr. Alice Marie Jacobs. He has focused primarily on student success, as evidenced by his support of "Operation Graduation" to improve graduation and retention rates for key cohorts.

Another of his priority initiatives has been to serve Danville's neediest population by establishing classes and bus transportation in the heart of a 1,500-resident housing project.

He has also expanded the College's program to provide local and affordable baccalaureate degrees through a "3 +1" model that enables students to take three years of classes at DACC and a fourth year online.

Dr. Nacco and his wife Cindy live in Danville. He serves on a number of local boards on behalf of DACC. These include the Danville Police and Fire Commissioners Board, the Vermilion County Workforce Development Board, Vermilion Advantage, the Danville Symphony Orchestra Board, the Presence Hospital Community Leadership Board, and the WorkSource Enterprises Board. His community involvement includes membership in the Danville Rotary Club and Kiwanis. He also plays clarinet for the Danville Municipal Band.

Dr. Nacco holds a doctorate in educational leadership focused on community colleges from Rowan University, a Ph.D. in English and American literature from Fordham University, a master's in English and American literature from St. John's University and a bachelor's degree in English literature from the State University of New York at Plattsburgh.

His prior experiences included election to the Vermilion County Board and to City of Danville government as an Alderman.



Mr. Terry T. Hill Term ends in 2023

Mr. Hill was elected to the DACC Board in 2017. A DACC graduate, he earned a bachelor's degree from Illinois Wesleyan and a master's degree from

Eastern Illinois University. As DACC's track-and-field coach, he won four straight national championships from 1993-1996 and was named "coach of the year" for all four years. After a 30-year career as a teacher in Oakwood, he became athletic director at Danville High School, retiring in 2007.



Mrs. Tonya S. Hill Term ends in 2021

A Catlin resident, Mrs. Hill is the Market President for Old National Bank. She is a DACC graduate and a Distinguished Alumna. Along with an associate in

applied science at DACC, she earned a bachelor's degree in Business from Eastern Illinois University. Mrs. Hill's influence extends throughout the Danville community. She has been president of the Danville Library Foundation and the A.L Webster Foundation. She's currently on the ONB Foundation Board, the DACC Small Business Development Center Board, Vermilion Advantage Executive Board, and others.



Mr. John Spezia Term ends in 2023

Coach Spezia was elected to the DACC Board in 2011 after having served as the DACC basketball coach for 23 years and DACC's athletic director for 19 years. A

two-time national coach of the year and athletic director of the year, he coached DACC to the 1991 NJCAA national championship. Coach Spezia won 354 games at DACC and a combined total of 530 games in schools and professionally. He was elected to the Hall of Fame for the National Junior College Athletic Association and for the Illinois Basketball Coaches' Association. He helped bring the NJCAA national men's basketball tournament to Danville in 1994, he assisted in ensuring that more than

200 of his athletes graduated to earn scholarships, and he launched summer camps for kids.

Mr. Wolfe was elected to the Board in 2013 and is the liaison to the Illinois
Community College Trustees'

Association. In charge of business

development and sales for Danville-based EnvirOx, Mr. Wolfe served as president of the Oakwood Community Unit School District #76 from 2001-2013. He is currently a member of the Danville Noon Rotary as well as the Board of Directors for the Danville Boys and Girls Club.

recipient of a Trustee Education award. Mr. Cheney has had a 70-year relationship with the College, which will continue as he joins the Foundation Board in July.




TEACHING AND LEARNING

Bachelor's Degrees: The 3 + 1 Program

This year the College introduced more than 30 new bachelor in science programs under the "3 + 1" model, thereby enabling students to earn an associate degree and a bachelor's degree locally and affordably. After graduating with an associate at DACC, students take an additional year of DACC classes and then a fourth year online from a partner university like Eastern Illinois University or Franklin University to complete a bachelor's degree.

Middle College

One way DACC enables key external stakeholders to participate in the student success agenda and improvement of student outcomes is through our Middle College program. Middle College turns around the lives of high-school students who have the brains to succeed, but lack the will and persistence. The program rescues atrisk juniors and seniors who are on the verge of dropping out of high school. Led by the Director of Adult Education, Laura Williams, the Middle College staff have served more than 180 students since the program began in 2013. With an average number of 45 in the program each year, these students complete nearly 750 credit hours annually. Almost 150 of the 180 students passed Middle College courses and achieved their personal goals, which ranged from earning a high-school equivalency to returning to their high school and graduating.



Bonus Classes

A prime example of how the College has changed policies and practices to remove barriers and foster student completion is through the addition of bonus classes. In Spring 2017, DACC launched a pilot program to offer a free-of-charge "bonus class" for students who register for at least 12 credits for the spring semester. The program was our experiment to improve student

success by providing students with an incentive to add an extra class to their schedule, and thereby get to graduation more expeditiously. The project came as a result of collaboration among a number of College leaders, and for the pilot, the group identified eighteen courses to list as bonus course options. For the Fall 2017 semester, the program will expand to 36 courses.

Basic-Skills Classes

The College introduced Accuplacer placement testing to replace the obsolete Compass assessment system. To implement Accuplacer, Student Services provided extensive training for Student Services

personnel and for the College to devise a method of interpreting Accuplacer test scores to determine college-readiness in math, reading, and writing.

TRiO Works!

Each year over more than two decades, DACC's TRiO program has helped hundreds of low-income students receive the support they need to propel them to success in college and in life. Led by Director Shanay Wright, the TRiO staff held its annual graduation and awards ceremony on May 3, 2017, with 45 TRiO students earning associate degrees and six receiving certificates this year. The event featured testimonials from two of the successful students, April Maruna and Lisa Gray. Award recipients

included the seven TRiO students who made the 2016 President's List and another seven who made the Honor's List. In addition, five students received the TRiO Financial Literacy Award and 33 earned Student Support Service scholarships. In addition, Business Professor Emily Crain and Biology Professor Carol Dunn earned the TRiO Teacher of the Year awards based on recommendations from TRiO students. This year, the program served 202 students.





Operation Graduation

Under Dean Stacy Ehmen, Student Services employs nationally recognized best practices to improve student success. These initiatives include the engagement of advisors with all new full-time and part-time students through a series of three phone calls during the fall semester. In addition, all new, part-time students are now required to meet with an advisor to create an academic plan before their first semester at DACC. For students who are lagging in their progress toward graduation, the staff provides "Intrusive Intervention" to come to the assistance of those in danger of not graduating on time. As a result of these efforts, DACC's graduation rate in 2017 increased to 38 percent.

Phi Theta Kappa

Students who achieve outstanding scholastic records and demonstrate qualities of good citizenship receive recognition through admission into Phi Theta Kappa. Phi Theta Kappa is the national honor society which aims to promote scholarship, develop character, and cultivate fellowship

among men and women students of two-year colleges. Iota Xi is the chapter of Phi Theta Kappa at Danville Area Community College. In the Spring of 2017, more than 30 students were inducted into PTK, bringing the current membership over 180.

Student Planner

In Fall 2016, the College installed a Student Planner records-andinformation system to improve the way we serve students. Student Planner is mobile friendly and accessible at all times. Real-time communications and purposeful tools enable students and advisers to map out academic journeys and monitor their progress. Academic deans can also pull reports showing future courses needed based on student plans to better build upcoming semester schedules. This creates a more effective set of course offerings during uncertain economic times.

Feeding the Needy

On Nov. 5, 2016, DACC students hosted the Eastern Illinois Foodbank's Foodmobile distributing 14,083 pounds of food to 558 individuals, more than half of them children under 18. Another chilling fact: Some of the recipients were current DACC students. Wind Energy Instructor Greg Hansbraugh helped clear space in the Technology Building as a storage facility for the food.

Mike Hinote, the security supervisor from G4S, and DACC's security supervisor Greg Fegett helped manage the crowds. The volunteers were mostly students from the College's PTK honor society and the Presidential Scholars, with Professor Ronnie Johnson and Registrar Cindy Peck coordinating the students' participation.





PN to RN in a Year

DACC's Nursing Department has introduced a new program to accommodate working practical nurses who want to improve their credentials and their salaries by advancing to become registered nurses. Under the direction of Dean Kathy Sturgeon and Nursing Director Mimi Skinner, DACC has introduced the Practical Nurse to Registered Nurse program. To support working practical nurses,

the program is part-time. However, DACC accelerates progress toward the RN as much as possible so that students can complete it in a year and a half. The first cohort of 16 licensed practical nurses will join DACC in the Fall. Even taking classes part-time, these students will be on track to graduate and take their NCLEX licensing exams by the Fall of 2018.

If that's not a sterling example of creative, entrepreneurial faculty thinking, nothing is.

While virtually every other Illinois community college had its federal Perkins funding reduced for FY 2018, DACC's allocation rose by \$20,000 to \$215,549. Most of the Perkins funding will focus on equipment to support career-and-technical education. For our culinary education and the College's intent to expand this from a certificate program to an associate in applied science, Perkins will fund a





"Second Chance" Pilot

DACC's "Second Chance" program was an idea that Vice President of Finance Tammy Clark-Betancourt and Controller Debbie Knight hatched in 2016 with the help of the College's Enrollment Management Team. The program addresses a mounting crisis as more than 2,000 students are unable to continue to

register as DACC students because they have a balance owed on their accounts. Since the Fall 2016 semester, all of these students were given a "one-time-only, take-it-or-leave-it" offer to have their debt forgiven if they exhibited an earnest commitment to attending classes and graduating. Of the students

eligible to participate, 16 applied and nine were approved by the Second Chance Team. Six of these students are active students in the program and are matriculated in areas of study that include welding, culinary, certified medical assistant, marketing, and criminal law.

Reaching Fair Oaks Residents

Since late December, DACC officials have met with Housing Authority leadership to address a long list of unmet educational needs for residents of the Fair Oaks complex and other facilities throughout Danville. To that end, the College installed a 10-computer classroom in the Housing Authority headquarters that is dedicated to DACC's on-site

classes such as GED and computer literacy. To accommodate residents who need classes on the DACC campus but face daunting transportation challenges, the Housing Authority stepped forward to provide a 15-seat minibus for DACC to use to shuttle Housing Authority residents. Beginning in the Spring 2017 semester, the first group

of twelve GED students began shuttling between the Housing Authority and our campus. The shuttle also runs every hour to the Vermilion County Works Center where, through the GOALS program, they work with clients to establish success plans for personal and professional achievement.

Community Education under Laura Hensgen has moved into a smaller but more prominent storefront at the Village Mall, and the move paid immediate dividends. Community Education enrollment increased as more people were able to find them in this new location and sign up for personal-enrichment courses. For the fifth year in a row, Community Education also played a key role in bringing free tax assistance to the community through the Volunteer Income Tax Assistance grant in partnership with Community Action of Fast-Central Illinois.

America Starts Here at DACC

In May 2017, the Adult Education Department began offering a sixweek citizenship class to prepare local residents for passing the US Department of Immigration and Naturalization test that will lead to their becoming American citizens. The new course contains a review of the citizenship application and helps build the essential proficiencies required for passing the Immigration and Naturalization test administered through the

Centralized Immigration Services. Under Adult Education Director Laura Williams, the program focuses on building mastery in reading, writing, and spoken English as well as how to succeed in an INS interview. Most important, the course ensures that these aspiring citizens understand the US Constitution, basic US History, the laws of the United States, and the symbols of American patriotism.

"Getting Ahead" in Fair Oaks

For two years, DACC's Career Services Director Carla Boyd has been holding classes on-site at the Danville Housing Authority facility in Fair Oaks. The program enables residents to envision a pathway out of poverty. The program helps individuals in poverty build their resources for a more prosperous life for themselves and their families. As a result, program graduates are eager to pursue the next step in their lives. Some residents are hoping to complete their highschool equivalency. Others aspire to upgrade their skills and find jobs. Others are looking to enroll in college and earn college degrees.

40 Years of Ag Excellence

DACC's Ag Club hosted one of the region's most popular events on Apr. 21: The 40th Annual Ag Day. Dozens of area agricultural organizations, businesses, and local FFA chapters exhibited their wares. The day's festivities included a barnyard petting zoo, pedal tractor pulls for

the children, tractors and farm equipment displays, and a tour through the DACC Julius W. Hegeler II Greenhouse. The event drew an estimated 2,000 attendees, including students from more than 15 local schools.

Rescuing Dislocated Workers

Vermilion County Works secured a \$135,000 grant from the Illinois Department of Commerce and Economic Opportunity to assist the dozens of workers who will be unemployed with the impending closing of Cell One in Danville. Under Executive Director Brian Hensgen, VCW funding enabled 30 of the former Cell One employees to receive training. Eight of them were already enrolled in nursing courses while working full time.

The American Job Center

This year DACC became the One-Stop Operator for the County's American Job Center, serving job seekers at both the Danville Campus and the Vermilion County Works facility on North Franklin Street in Danville. As such, the College manages partner agencies that provide other "wrap around" services, including the Department of Human Services, the Department of Rehabilitation Services, and the

Illinois Department of Employment Security. An essential strategy to support DACC's success would be to provide the public with seamless services ranging from basic-skills instruction and occupational training to job preparation and placement. Brian Hensgen was appointed the Executive Director for the Center in a promotion from his prior position directing VC Works.

Career Fair

On Apr. 19, more than 1,200 students and the public attended the Career Connections Job Fair. DACC's Career & Employment Services Center staff hosted the Career Fair, which featured more

than 50 area employers hoping to fill job vacancies at their companies. They set up desks and conducted nearly 70 on-the-spot interviews. At least 20 of the people interviewed received job offers.

Corporate Education Nets \$300,000 Annually

DACC's Corporate Education Department under Director Stephanie Yates provides customized training for prospective and incumbent workers at more than 30 Danville companies—more than half of them manufacturing businesses. The client list includes Danville Metal Stamping, EnvirOx, McLane, Mervis Industries, Presence, Quaker Oats, Sygma Network, thyssenkrupp Crankshaft, thyssenkrupp Presta, Towne Machine, Tridan, Trigard, VA Illiana Healthcare, Viscofan, Walgreens Accounting, and Watchfire Signs.

Jobs Galore in Danville

Vermilion Advantage conducted a survey of more than 30 local companies—many of them manufacturers—and discovered that local industry plans to hire 1,700 employees between now and the end of 2018. For a City with 31,000 citizens, that's a job boom of seismic proportions. At the top of the needs list for local businesses are 230 tractor-trailer drivers, 221 warehouse selectors, 176 computer numerical control or CNC operators, 151

warehouse loaders and stock handlers, 143 machine production operators, 142 food-service workers, and 54 customer-service representatives. There are also anticipated shortages for forklift operators, healthcare positions (nurses, nursing aides, physician assistants, and physicians), supervisors, engineers (electrical, computer-software, quality control), and accountants.

Lt. Governor Praises College Express

On May 17, Illinois Lt. Governor Evelyn Sanguinetti visited DACC to recognize the College Express program as a Best Practice for shared services. College Express was recently featured in the Journal of Local **Government Shared Services Best** Practices. The partnership includes the Vermilion Vocational Educational Delivery System schools, DACC, and Vermilion County Works. For more than a dozen years, the partners have teamed up to deliver high-quality career and vocational education to high-school students. DACC provides the facilities and instructors for programs ranging from computer programming to welding. VVEDS recruits and supports students from eight school districts throughout Vermilion County. Vermilion Advantage leverages relationships with partner industries so that graduates are able to enter seamlessly into careers.


State Award for Child Development Center

Hoopeston Economic Development

Each month, Hoopeston Center Director Karla Coon hosts the meeting of the Economic Development Committee, a small group of dedicated elected officials and community leaders who work together to address community needs in revitalizing the regional economy. Along with providing noncredit and credit classes in programs ranging from certifiednursing-assistant training to general-education courses, the

Center serves as the catalyst for economic growth. Among those who typically join Ms. Coon for the monthly meeting are Hoopeston Mayor Bill Crusinberry, County Board Member (now County Treasurer) Darren Duncan, DACC President Nacco, Hoopeston School Superintendent Hank Hornbeck, Vermilion Advantage's Logan Cronk, and several others. Bill Nichols chairs the committee.

New Tutoring Program

In 2016, the Center introduced a new initiative titled, "Confidence Builders Tutoring Program" that has engaged students and parents throughout the Hoopeston School District. The Center has enlisted a number of retired teachers to serve as volunteer tutors at the Center for children from third grade and up as well as adult learners. Parents who would like their children to receive

tutoring would meet with school and College administrators for a briefing. Hoopeston's grade school and high school both participated. The tutoring takes place at the College's Center, and isn't restricted to the school children. The parents themselves are offered a class in common-core mathematics so that they can help their children at home.

Dr. Jacobs had the vision and determination to address the community's need for an extension center in northern Vermilion County. On June 21, 2012, the College announced the plan to renovate the medical building and land (located on 847 East Orange Street) that Hoopeston Hospital had donated to DACC. After a year of renovation, DACC opened the center on Sept. 9, 2013, with the first DACC classes held on Sept. 16. In the past year, DACC has explored ways of expanding both the credit and noncredit services the Hoopeston Center provides.





Growing Revenue

Due to the continuing shortfall in State funding, President Nacco indicated that the College would need to continue to adhere to Essential Spending Guidelines, and laid out each of the measures, which included close scrutiny over all expenses not directly related to teaching and learning. To that end, **Executive Vice President Dave** Kietzmann led a faculty-and-staff team named REAP—charged with developing a Revenue Enhancement Action Plan. Among the initiatives discussed and implemented were revenue opportunities through bachelor's-degree partnerships (3 + 1) and programing to address a critical shortage in regional K-12 teachers. The team is investigated

DACC HISTORY



DACC's Founding President Mary Miller

May 13, 1946: Mary Miller founds DACC as an extension center of the University of Illinois in 1946.

August 22, 1949: DACC becomes a public junior college under Danville Public Schools.

September 30, 1951: The College receives the name Danville Junior College.

Jan. 11, 1964: The Danville Area Community College Foundation is formed as a nonprofit 501 (c) 3 to support student scholarships.

August 1, 1965: The College acquires seven historic buildings from the Veterans Administration on East Main Street, moving to its current 75-acre campus.

September 12, 1965: The Danville Junior College Foundation launches a fundraising drive to support the move to the new campus.

April 11, 1966: DACC becomes an independent two-year area college with the election of its first Board of Trustees and the establishment of District 507.

May 17, 1969: Dedication of the Ornamental Horticulture Center

April 30, 1970: Opening of the Mary Miller Center and Gymnasium.

July 1, 1972: Dr. William Langas becomes DACC's second president, replacing founding President Mary Miller after her 26-year tenure.

July 9, 1972: Completion of the Technology Center, which includes the South Bay, Weld Shop, Machine Shop, and offices.

June 15, 1979: Dr. Joseph Borgen becomes DACC's third president.

Sept. 1, 1979: The name Danville Junior College is changed to Danville Area Community College to be more reflective of the services rendered as a comprehensive community college.

Sept. 3, 1981: Dr. Ronald Lingle is announced as DACC's fourth president.

June 1, 1982: Renovation of the Bremer Theater and construction of conference rooms.

Sept. 10, 1982: Renovation of the Clock Tower building.

Feb. 14, 1987: Completion of the expansion of the Mary Miller Center's first and second floor for Math and Science education.

July 1, 1989: Dr. Harry Braun is named DACC's fifth president.

Sept. 3, 1992: Expansion of the Technology Center and dedication in the name of former DACC President Harry Braun to open classrooms and offices on the north and west wings.

Mar. 16, 1994: DACC hosts the first of what will be 24 consecutive years (including this year) as host of the NJCAA Division II national men's basketball tournament.

Aug. 18, 1997: Dedication of the Child Development Center.

July 1, 1998: Remodeling of the Bremer Theater is completed.

Dec. 15, 1998: Job Training Partnership/Vermilion County Works moves to new location at 407 N. Franklin Street.

Sept. 1, 1999: Dr. Alice Marie Jacobs becomes DACC's sixth president.

Nov. 1, 1999: Opening of Lincoln Hall.

May 17, 2000: Remodeling completed for the first floor and basement of the Clock Tower Library.

Apr. 1, 2001: Remodeling of the art and painting rooms in the Clock Tower building.

Oct. 24, 2002: Completion of renovation \$30 million renovations to Cannon, Prairie, and Vermilion halls.

Sept. 30, 2004: Dedication of the First National Bank Collection of Public Art in the Clock Tower Center.

Sept. 10, 2005: Community Education begins holding classes in a store at the Village Mall.

Nov. 7, 2007: Dedication of the Bremer Conference and Workforce Development Center.

July 31, 2009: Demolition work completion on buildings 5, 9 and 10 as well as underground tunnels.

Oct. 10, 2009: Julius W. Hegeler II Garden Gateway is dedicated.

Mar. 29, 2011: Opening of the Julius W. Hegeler II Greenhouse.

July 11, 2011: Construction of the Wind Turbine Training Tower, which is located on farm ground.

Oct. 24, 2012: Completion of Mary Miller Complex expansion and renovation and the naming of the William B. Black Health Professions Center.


July 15, 2013: DACC is named an Achieving the Dream Leader College.
