## **Transfer Admission Requirements:**

- 1. 2.50 GPA (4.0 scale). Average GPA for admission is 2.75-3.45.
- 2. Completion of the following tool courses with at least a C grade. A D grade will not be accepted and includes both grades for repeats of classes. Accounting majors are required to have a minimum 2.50 GPA (4.0 scale) for Accounting 131\* and 132\* (including repeats).

3. Students are urged to apply in September for the following fall semester. It is **imperative** that new transcripts be sent to ISU after each grading period until entering the institution.

## Notes:

- 1. Accounting majors may specialize in Financial Accounting, Business Information Systems, or Accounting Information Systems.
- 2. Insurance majors may specialize in General Insurance or Insurance-BIS.
- 3. Management majors may specialize in Organizational Management, Operations Management, or Human Resource Management.
- 4. Marketing majors follow a comprehensive course of study.
- 5. International business majors should complete at least 4 semesters of one foreign language in their appropriate sequence. It is highly recommended that all other business majors have two years of one high school foreign language or one year of one college level foreign language.
- 6. Cost Accounting (CACC 166) will transfer as a general elective and students may elect to take it in addition to CACC 101 and 105 to better prepare themselves for ISU's managerial accounting. ISU strongly urges students to take Cost Accounting.
- 7. Students can meet ISU's Global Studies graduation requirement by completing

POLI 160, GEOG 134, or ANTH 107 as a DACC social science requirement. If a different social science elective is completed, the Global Studies requirement must be met at ISU. There are dozens of courses to choose from in this area once the student is enrolled at ISU.

- 8. Effective Fall 1992, new students or re-entering students absent more than two years and seeking an ASA degree are required to take at least one course with human relations content. See your counselor for list of courses that fulfill this requirement.
